Any previous underperformance by BGI must be made up before their performance fee is payable. The BGI Fund will form part of this investment options from 1 June 2007.
A performance fee calculated at 10% (GST exclusive) on the Global Trading Strategies Trust II's (GTSII) performance above its benchmark (UBS Bank Bill Index).
