The complete list of current investment charges for the Ibbotson Investment Trusts and Managed Investments as shown in this report are correct at the time of printing. These are subject to variation by the investment manager and the charges may be increased to include such costs as the GST.

Any previous underperformance by BGI must be made up before their performance fee is payable. The BGI Fund will form part of this investment options from 1 June 2007.

A performance fee calculated at 10% (GST exclusive) on the Global Trading Strategies Trust II's (GTSII) performance above its benchmark (UBS Bank Bill Index). Any previous underperformance by GTSII must be made up before our performance fee is payable. The GTSII will form part of this investment option from 1 June 2007.
